Through our Child's Smile program two state ran orphanages in Ukraine has been receiving monthly aid for children from us. During 3rd quarter of 2020 we started providing on going support with food, clothing and medical supplies for adult mental facility.

Hope for Ukraine was able to supply on a monthly basis grocery packages to struggling families and individuals. Supplied clothing and shoes for those in need.

In Israel we have been working with our partners building homeless shelter and running a soup kitchen for poor. This year we have also helped families in Moldova and Armenia through our Family Support project.

Through our Family Support program we are funding building a house for Blyznak family in Ukraine who live in extreme poverty.

We help poor children get access to free education through our weekly after school tutoring program.;Families in need access to vital support and people with serious illnesses access to quality;medical treatment.

Over last year we helped many sick children get access to quality healthcare. On the ongoing bases we support many HIV positive children and their families. Hope For Ukraine has been supporting school of 200 children with mental disabilities in Ukraine, we are helping children with school supplies and educational aids. We have been involved in building Children' Rescue Center in Lviv, Ukraine that will serve as educational center for poor children once it will be open.

Our Medical Support project funded life changing surgery for young lady in Ukraine Eva as well as we are involved with providing on going support for family of boy name Mark who is battling vitamin D resistant rahit (VDDR2a).
