As a full scale invasion of Ukraine by Russian army begun on 02/24/22 Hope For Ukraine mobilized all our resources to help civilians that been effected by this war. Through our Family Support Project we have provided 62 million meals last year to individuals and families who lost access to basic food and necessities throughout the war-ravaged country of Ukraine. Through multiple donation sites all across United States we collected and shipped 1120 tons of humanitarian from the United States to Ukraine in 2022.

Our refugee center in Lviv, Ukraine opened its doors for families fleeing the war from day one. In 2022 refugee center in Lviv provided 1310 displaced families with temporary shelter. (See Sched O for full statement)

Through our Medical Support Project 23 hospitals In Ukraine received critically needed medical supplies in 2022. On the regular basis we have provided free medical and dental treatments for internally displaced families all across Ukraine. Our volunteers working full time on the ground connecting individuals in need of medical attention with medical professionals that can help them. Hope For Ukraine has provided aid for individuals and hospital in Myklayev, Kherson, Kirovograd, Donetsk, Kriviy Kig, Kharkiv, Kyiv and Lviv regions in 2022.

A Child's Smile Project in Ukraine giving thousands of children in Ukraine hope. We will not let Russia steal childhood from Ukrainian kids. We are sponsoring number of after school programs for children all across Ukraine. On average 550 children weekly get access to arts, music and sports programs sponsored by Hope of Ukraine. During holiday season 2022 through our "Joy of Giving" campaign we delivered gift boxes to more than 5600 children throughout Ukraine. Every month we organized 2-3 children's events to help kids in Ukraine forget about war and be children again.
